### Smart & Start Italia 1/2



WHO Innovative startups
 Teams which set up new companies
 Foreign companies which set up Italian branches

WHAT • Development of innovative technological solutions, digital economy and exploiting R&D results

SUBSIDIES • Interest-free loan up to 80 or 90%

Projects based in Southern Italy or in municipalities hit by earthquakes repay only 70% of the loan amount

# ALLOWABLE EXPENSES

# DEBT CONVERSION

 Startups which successfully complete Smart&Start, may convert the loan to a grant up to 50% if investments in the company's capital are in equity or quasi-equity made by third party investors or shareholders


### Resto al Sud 2/2



SUBSIDIES • 50% grant and 50% bank loan (zero interest) backed by Fondo di Garanzia + liquidity bonus (€15k if individual company, up to €40k for corporations)

EXPENSES • Up to 200k € investments (€60k for individual companies)

WHERE Abruzzo, Basilicata, Calabria, Campania, Molise, Puglia, Sardegna, Sicilia
 Comuni Cratere Sismico di Lazio, Umbria e Marche
